

FIRST RESEARCH-BASED CYBER BULLYING AWARENESS CURRICULUM LAUNCHED IN PARTNERSHIP WITH LEADING EDUCATION ORGANIZATIONS

The solution does not lie with 'stranger danger' fear tactics or filtering, but with prevention strategies where students and schools "own" the problem

BERNARDSVILLE, NJ – January 12, 2009 – CyberSmart! announced today the release of the CyberSmart! Cyberbullying Package, a positive and empowering suite of K-12 lessons provided free to schools in partnership with The National School Boards Association's Technology Leadership Network, the Character Education Partnership, the National Association of School Psychologists, and the National Cyber Security Alliance.

The lessons adopt an integrated approach, based on current research findings and best practices from the fields of cyber security, school violence prevention, and character education to impact behavioral change. The resulting package of materials focus on developing critical thinking and decision-making skills, guiding students to define the problems and issues themselves and "own" them. Without this ownership, no behavioral change can occur.

"The four preeminent educational organizations distributing this program reach into nearly every school and community in the United States. Our message is that cyberbullying can be proactively addressed by schools at the same time they embrace the use of online tools and resources to engage students, foster 21st century skills and prepare our children to achieve in today's digital society," stated James Teicher, CEO of CyberSmart! The CyberSmart! Cyberbullying Package includes standards-based, non-sequential lessons designed to be integrated into the existing curriculum by classroom teachers as compared to scheduled one-time assembly programs that can disrupt classroom schedules. It also includes home connection materials and prevention activities that extend classroom learning out to the school, families, and the community. An extra bonus - optional Web 2.0 activities so that students use the web resources to spread the positive, empowering prevention message.

"Cyberbullying is a concern among parents and educators, but it is a manageable problem that can be addressed in a positive manner to both empower safe, ethical online use and support schools' ability to enhance instruction with technology.
